All students who successfully complete the certificate are eligible to transfer credits into the in-person or online Master's degrees in Public Health or Health Administration, both offered in the Department of Health Policy and Management, Milken Institute School of Public Health, if admitted. Credits also may apply to the Master of Professional Studies in Paralegal Studies.

Course Sequence

INTRODUCTION TO HEALTHCARE CORPORATE COMPLIANCE (3 credits)

Five-day In-classroom Residency at GW's Graduate Education Center in Alexandria, VA

This course provides an intensive in-person/ on-site overview of healthcare corporate compliance core elements and strategies for compliance plan development and implementation. It introduces key statutes, regulations, policy guidance, and enforcement initiatives that are the framework for developing a compliance program.

COMPLIANCE WITH SPECIFIC LAWS AND REGULATIONS (Two 3 credit courses) Six-month Online Learning Segment

These courses cover discrete compliance topics providing students with an in-depth exploration of the healthcare laws and regulations of particular importance to regulators and industry.

CASE STUDIES IN HEALTHCARE CORPORATE COMPLIANCE (3 credits)

Three-day Capstone Residency in Alexandria, VA

This course offers students the opportunity to apply the principles, laws, and regulations learned during the program. Utilizing a case study approach, students investigate and analyze compliance issues and test their diagnostic and remediation skills in applying this knowledge to real-world situations.

Faculty

Core faculty are drawn from experts across The Milken Institute School of Public Health. Faculty also include representatives of a number of law firms with expertise in healthcare corporate compliance, including program partner Feldesman Tucker Leifer Fidell LLP and McDermott Will & Emery LLP. Guest speakers and panels include representatives from federal and state agencies that enforce key compliance-related laws and federal and/or state policymakers, representatives from the healthcare industry, experienced corporate compliance officers, and plaintiffs' attorneys.
