Where do I find the webinar promo codes?


Option 1: By Email from FTLF

Option 2: On the Membership Course Page


- 1. Navigate to the Federal Grants Training Membership page




3. Click the *Webinars* tab located on your left-hand side and then click *Start* or *Review* (the button changes once you have accessed the webinars)

You have multiple options for viewing the monthly webinars.


Option 1: Registering with a Promo Code
